#### HISTORY OF MOHELI

The small island of Moheli is part of the Comoros archipelago off Africa's east coast. Inhabited since the 6th century, it was settled by Bantu speakers and later Shirazi Arab colonists who blended African and Arabic culture. In the 1800s, Moheli became part of the Ndzuwani sultanate on Anjouan island. Made a French protectorate in 1886, it was colonized until the Comoros gained independence in 1975. Moheli joined the new republic as a semi-autonomous island state. Today, Moheli has around 50,000 inhabitants. Its economy relies on agriculture, fishing and crafts, with growing tourism. The tropical island is renowned for its forests, beaches, marine parks and UNESCO-listed Moheli National Park.

# MWALI INTERNATIONAL SERVICES AUTHORITY

As per the Comoros Union Constitution, each island enjoys autonomy, with its own President or Governor, Parliament, and Constitution. Mwali island operates its financial sector independent of the Central Bank of Comoros. Its internal legislation for the management of Offshore Financial Services dates back to 1998.

The Mwali Constitution empowers the independent Companies Registry, Banking, Trading, and Gaming. Articles 36–38 elaborate on public and private patrimony, including the M.I.S.A. It also confirms Mwali International Services Authority's continued authority, the exclusive regulatory body for Mohéli (Mwali), overseeing financial services and licensing.

Amendments in 2013 to banking and other licensing laws, and 2019 regulations on virtual currencies underscore the evolving legal landscape. Presently, M.I.S.A. has registered 12,000+ companies, encompassing insurance, gambling, trust, brokerage, and international banking. Remarkably, the Mwali register stands as Africa's largest international companies register.
